It is my firm belief that the officials that represent our communities should be representative of the diversity that exists within the community they serve; and should represent a strong voice for those populations who may otherwise not be heard. As a member of the BIPOC community and mother of a bi-racial child with dual learning exceptionalities, I am acutely aware of the unique challenges that can arise when navigating the education system within this realm not only as a student, but as a parent. Moreover, as a person who is blind, I am also acutely aware of the challenges that arise as a student with a significant disability, and the sometimes-insurmountable fear that arises from learning to self-advocate.

Over the years, I have been engaged in various initiatives both at the local school and board levels whereby I have been able to help push forward the mandates and goals of the GECDSB. Of note, I served on the Greater Essex County District School Board Prent Involvement Committee (GECPIC) and as the Chair of the John A McWilliam Public School's School Advisory Council (SAC) for several years, where, among many things, I was able to create, promote and facilitate the delivery of various workshops surrounding student mental health, wellbeing, and learning success. Moreover, I had the distinct pleasure of working with the GECDSB on the Anti-Racism Regulation Committee whereby I was able to interface with community leaders in this space to ensure equity is upheld within the policy creation at the Board.

In my work as the Clinical Director for a multi-location clinic serving Southern Ontario, I have had the privilege of not only providing mental health supports to innumerable children and adolescents in the communities we serve; but have played an integral role in the assessment and development of supports for countless students diagnosed with learning disabilities, ADHD, and neurocognitive disorders. This role has naturally also engaged me in the important task of coaching parents through navigating our education system and advocating for their children's right for learning success.
