1. Call to Order

The meeting was called to order at 1:02 p.m.

2. Land Acknowledgement

We acknowledge that we are on land and surrounded by water, originally inhabited by Indigenous Peoples who have travelled this area since time immemorial. This territory is within the lands honoured by the Wampum Treaties; agreements between the Anishinaabe (Ah-nish-e-naa-bay), Haudenosaunee (Hoe-den-oh-show-nee), Lenni (Len-eh) Lenape (Le-naw-pay) and allied Nations to peacefully share and care for the resources around the Great Lakes. Specifically, we would like to acknowledge the presence of the Three Fires Confederacy, Ojibwe (Oh-jib-way), Odawa (Oh-dah-wah), Potawatomi (Paw-taw-watt-ohme) and Huron/Wendat (Wen-dat) Peoples. 6. Business Arising as a Result of the Minutes

7. Special Education Presentation

L. Brode presented Hack the Holidays. Hack the Holidays is a collaboration between GECDSB and John McGivney School Authority. This year GECDSB's Special Education team partnered with Student Success. Mainstream secondary students gained hands-on experience to support local families and foster a strong sense of community. We hosted two student events one at Tecumseh Vista Academy Innovation Centre Event where robotic students and computer engineering student from across GECDSB came together for a full day of adapting toys and building switches. The second was held at Belle River District High School where grade 11 and 12 computer engineering students spent the day adapting toys. Parents were invited to attend an event held on December 3rd, 2024, where the could select a switch and an adapted toy. They also had an opportunity to meet with Occupational Therapists to support families on facilitating use of the toys and switches and Speech Language Pathologists to learn how adapted toys can support communication. They could also explore a Maker's Making Change station to discover

resources and register for adapted gifts. 27 families attended the event, and we hope to grow it in the future.

The team was also excited to share a Brain Computer Interface (BCI) project that was started last school year. L. Brode helped to adapt a two-seater bike that can now be used with BCI equipment. The Team has also created a Switch Library that Teachers can access through the Media Centre.

8. Special Education Updates

Update on Restructuring Supports for Special Education, C. Mills shared that he would continue to update the Committee at where we are at in the process. Principal were provided information to share with families. Parent consultation has started, and we can review that in the new year. We will also look at Community Partners in the new year. We continue to have open lines of communication and invite feedback/concerns from our families and this Committee. We are starting to see some themes develop, similar to what the committee expressed, like academic support, social/emotional support, resources, IEP development, etc. Feedback will be shared with our Senior Team, and we will look at each school.

Professional Development Updates

L. Bates shared that a lot of learning is going on not only in the schools but in the community. The feedback for November 15th Professional Development Day has been very positive. We received emails from staff: fantastic presentations, appreciated the real examples, fun ideas and small group setting, teams continue to ask for this type of opportunity. In the new year we will continue with Universal Design and Differentiated Instruction learning.
