Call to Order

The meeting was called to order at 1:04 p.m.

2. Land Acknowledgement

5. Business Arising as a Result of the Minutes

6. Special Education Presentation

Working with Students who are Blind or Low Vision

C. Townsend and P. LaSala presented to SEAC their roles as Blind/Low Vision Itinerant teachers. They work with a wide array of students in kindergarten to grade 12. Some of the services they provide for Low Vision students; trial, order, and train high-and low-tech devices, monitor progress, order texts in appropriate mediums, review and interpret ophthalmology reports and determine how student use their functional vision to access the curriculum. For Braille users they provide 1:1 support from the Teacher of the Visually Impaired with a focus on independence, safe travel, braille instruction, as well as, using a variety of mediums. They work with the classroom educators to determine modifications and accommodations to the curriculum. For Students with Multiple Exceptionalities, that could range from low vision to blind or deafblind and may have Cortical Vision Impairment. These students may not be Braille users. Students are often placed in GAINS or STEPS classrooms and have access to multiple sensory tools that can help stimulate their visual, audible and tactual senses. They provide equipment, ideas and support to the classroom teacher. In all areas they also assist with their IEPs.

7. Special Education Updates

PD Updates

K. Sweet shared the professional development for the month of April. STEPS Department Resource Development, the Special Education and Program Department partnered together to provide a collaborative working session. They planned and developed resource material for K Courses. Staff reviewed board resources that are available, designed lesson plans and created materials for their STEPS classrooms.

New to GAINS, teachers had a half day observation in either a GAINS or STEPS classroom. The afternoon session was hosted by Kelsey Smith, 21st Century Teacher

& Education Consultant at John McGivney School Authority. Kelsey shared programming ideas and adapted lessons.

9. Association Reports

- M. Fuduric, Learning Disability Association of Windsor-Essex County We have moved to a new location. Our programing guide was sent out recently and shared with the SEAC. The LDAWE Scholarship is out, applicants must be registered to attend a full-time program at St. Clair College or the University of Windsor.
- T. McCarthy, Autism Ontario Scholarships are out and information was shared with SEAC. Autism Ontario is accepting online application from April 1-April 30, 2024. The Eleanor Ritchie Post-Secondary Scholarship is awarded to a student on the autism spectrum. The Jeanette Holden Post-Secondary Scholarships for siblings of a person on the autism spectrum who are entering their first year of post-secondary program. And the MacDonald Family Post-Secondary Scholarship is for students with a parent on the autism spectrum who are entering the first year of post-secondary. Last year Autism Ontario called for increased funding to the Ontario Autism Program (OAP) that would reduce wait times and provide greater access to core services for families, they welcomed the announcement of a \$120 million increase to the OAP.
- S. Yang, Fetal Alcohol Spectrum Disorder/Ontario Network of Expertise the FASD Caregiver Support Group held a brainstorming session on April 16th, the flyer was shared with the group. The FASD program is in the process of applying for a new grant to fund the caregiver support group activities. They will be hosting FASC Caregiver Support Group sessions but will not have formal presentations until further funding is approved. The focus will be on providing emotional support for caregivers instead of a formal presentation.
